# BOTANALYTICS TERMS OF USE

EFFECTIVE DATE: May 25, 2018

#### 1. INTRODUCTION

Thank you for choosing Botanalytics! These Terms of Use (the "Terms") cover your rights and obligations relating to your access and use of the Botanalytics website, service, and related services, which may include a web application, mobile application, and/or other related services provided by us (collectively, the "Service"). All references to "we", "us", "our", "or "Botanalytics" refer to Botanalytics, Inc., a Delaware corporation. All references to "you", "your", or "Client" refers to the user of the Service, which includes individuals and entities that seek analytics and metrics in order to improve the performance of chatbots. All references to "your End-Users" refer to the Client's users, which include individuals who interact with your chatbots. In addition to these Terms, please review the Botanalytics Privacy Policy (https://botanalytics.co/privacy), which describes our practices related to collection and use of your information and your End-Users' information to provide the Service. These Terms apply to our Privacy Policy as well and both these Terms and our Privacy Policy have been updated to comply with the requirements of a new data privacy law known as the EU General Data Protection Regulation ("GDPR"). By using the Service, you represent and agree that you have read, understand, and agree to be bound by both these Terms and our Privacy Policy as binding agreements. Further, you agree that these Terms and our Privacy Policy apply to your past use, if any, of the Service prior to the Effective Date.

However, to the extent Client enters into a separate agreement that specifically modifies these Terms, the terms of the separate agreement shall apply where they conflict with these Terms.

PLEASE CAREFULLY READ THESE TERMS, AS THEY CONTAIN IMPORTANT INFORMATION ABOUT YOUR RIGHTS AND RESPONSIBILITIES, INCLUDING LIMITATION OF OUR LIABILITY AND BINDING ARBITRATION. IF YOU DO NOT ACCEPT THIS AGREEMENT IN ITS ENTIRETY, YOU MAY NOT ACCESS OR USE THE SERVICE.

### 2. AGE POLICY; PERMITTED USERS

We do not intend that the Service be used by anyone under 18 years old. #### 3. OVERVIEW OF SERVICE

The Service fundamentally provides a conversational analytics and engagement tool for chatbots, which can be used to improve the performance of bots. The Service can be used to improve communication between your bots and your End-Users, but by using the Service, you agree that Botanalytics is not a party to any arrangement or business relationship between you and your End-Users.

### 4. END-USER DATA

As a key aspect of the functionality of the Service, Botanalytics collects information submitted by, and about, your End-Users ("End-User Data") as described in our Privacy Policy. You agree Botanalytics is not responsible for any such End-User Data, except to the extent required by GDPR and as described in the terms of the Data Processing Addendum (available here: <a href="https://botanalytics.co/dpa">https://botanalytics.co/dpa</a>), which apply to your use of the Service if you use the Service in connection with End-Users in the European Economic Area or Switzerland. Further, you are solely responsible for obtaining your End-Users' consent to collect and share End-User Data with us in connection with your Service in compliance with GDPR.

As a core aspect of the functionality of the Service, you may provide us with information about yourself and your End-Users, by giving us access to information collected by third parties, and by using the Service. We will notify you promptly of any such claim and will provide you with reasonable assistance, at your expense, in defending any such claim, provided, however, that our failure to so notify you shall not relieve you of your indemnity obligations, but instead shall reduce those obligations by the amount of damages or increased costs and expenses attributable to our failure to give notice. We reserve the right to approve counsel retained by you, to take control of the defense (at our expense) of any claim for which indemnity is required, and to participate in the defense of any claim (at our expense) for which indemnity is required. You may not settle any claim without our prior consent.

#### **20. DISPUTE RESOLUTION**

You agree to resolve any dispute, claim, or controversy with Botanalytics arising out of or relating to your use of the Service in the following manner. First, we both agree to attempt in good faith to resolve the dispute informally by contacting each other by email (you can email us at <a href="hello@botanalytics.co">hello@botanalytics.co</a>). Second, if the dispute is not resolved through informal resolution, we both agree to attempt in good faith to resolve the dispute through mediation administered by JAMS, which shall take place in San Francisco, CA, and the costs of which shall be divided equally between you and Strive. Third, if the dispute is not resolved through informal resolution and mediation, we both agree to participate in binding arbitration administered by JAMS, which

shall take place in San Francisco, CA.

Either you or we may bring a lawsuit solely for injunctive relief without first engaging in the dispute resolution process described above.

We both agree that, in the event of arbitration, or in the event of a lawsuit as permitted by this Section or otherwise, the prevailing party shall be entitled to costs and fees (including reasonable attorneys' fees). Arbitration pursuant to this Section shall be confidential, and neither you, nor Botanalytics, nor the arbitrator may disclose the existence, content or results of any arbitration, except as may be required by law or for purposes of enforcement or appeal of the arbitration award. Judgment on any arbitration award may be entered in any court having proper jurisdiction. There shall be no right or authority for any claims subject to this arbitration clause to be arbitrated on a class action or consolidated basis or on bases involving claims brought in a purported representative capacity on behalf of the general public (including, but not limited to, as a private attorney general). If any portion of this arbitration clause is determined by a court to be inapplicable or invalid, then the remainder shall still be given full force and effect.

YOU AND BOTANALYTICS EACH HEREBY IRREVOCABLY WAIVE ANY AND ALL RIGHT TO TRIAL BY JURY IN ANY LEGAL PROCEEDING ARISING OUT OF OR RELATED TO THIS AGREEMENT OR THE TRANSACTIONS CONTEMPLATED HEREBY.

Nothing contained in this Section shall limit our ability to terminate, or otherwise take action related to, your account as provided in these Terms.

### 21. GOVERNING LAW, VENUE, & PERSONAL JURISDICTION

These Terms shall be governed by the laws of the State of Delaware, without regard to conflict of law provisions. In the event that a lawsuit is filed where permitted under the provisions above, or in the event that the provisions above are found not to apply to you or to a given dispute, we both agree that any judicial proceeding will be brought in the federal or state courts of San Francisco County, CA. Both you and we consent to venue and personal jurisdiction there.

### 22. SEVERABILITY WAIVER

If, for whatever reason, any term or condition in these Terms is found unenforceable, all other terms and conditions will remain unaffected and in full force and effect. The failure to enforce any provision of these Terms is not a waiver of our right to do so later, and no waiver shall be effective unless made in writing and signed by an authorized representative of the waiving party.

### 23. CHANGES TO THESE TERMS

Botanalytics reserves the right to change these Terms from time to time, with or without notice to you. If you continue to use the Service, you consent to the new Terms. Any changes to these Terms will become effective on the "Effective Date" indicated above. If you continue to use the Service after the Effective Date, you consent to the new Terms. Botanalytics will always have

the latest Terms posted on the Service.
